GENERAL PRICE LIST (GPL)

Prices are effective as of January 1, 2026 and are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

DIRECT CREMATION PACKAGE PLAN REQUESTED BY MOST FAMILIES \$1,992.00

Our charge for a direct cremation (without ceremony) includes: basic services of Funeral Director and staff, a proportionate share of overhead costs, removal of remains within San Diego County to our facility in El Cajon, CA, shelter of remains, transportation to the crematory, a state-mandated combustible cremation container, securing the necessary authorizations, obtaining the required Disposition Permit (1), and the mandatory Dept. of Consumer Affairs (DCA) fee. We offer the choice to have cremated remains scattered (unattended) at sea by Neptune Society, (or) returned to next of kin (or) delivered to a local cemetery, in a durable plastic urn.

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF & OVERHEAD \$1,400.00

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) Includes conducting the arrangements conference, planning the funeral, sheltering the remains, securing necessary permits, and coordinating the cemetery or crematory arrangements. In addition, this fee includes a proportionate share of our basic overhead costs.

TRANSFER OF REMAINS TO NEPTUNE SOCIETY (add \$5.00 per mile in excess of 60 miles, one way) \$570.00

EMBALMING OF BODY \$600.00

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as Direct Cremation or Immediate Burial.

FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME \$2,700.00

Includes basic services of funeral director and staff, a proportionate share of overhead costs, transfer of remains to Neptune Society of San Diego, shelter of remains, embalming, and transport to San Diego International Airport in utility vehicle (casket not included**).

IDENTIFICATION (ID) VIEWING (2 person maximum) \$300.00

Use of facilities for 15-minute, informal viewing without embalming or cosmetic improvements; subject to Director approval.

IMMEDIATE BURIAL (Casket NOT included) \$2,100.00**

Our charge for an unwitnessed, immediate burial (without ceremony) includes: basic services of Funeral Director and staff, a proportionate share of overhead costs, removal and shelter of remains, transportation to local cemetery, securing necessary authorizations, required Burial Permit and mandatory DCA fee.

LOCAL DELIVERY of CREMATED REMAINS or DEATH CERTIFICATES (per trip charge) \$50.00

OTHER PREPARATION OF BODY (POST-EMBALMING) \$400.00

Involves re-dressing and casketing the body after embalming, includes cosmetics application, hair styling, and nail painting.

PRIVATE TWO-HOUR BOAT CHARTER for SIX \$1,000.00

PRIVATE TWO-HOUR YACHT CHARTER for up to TWENTY \$2,000.00

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME	\$2,100.00
Includes basic services of funeral director and staff, a proportionate share of overhead costs, and transfer of remains to Neptune Society from other local funeral home.	
RUSH CREMATION (<u>requires approval</u>)	\$1,000.00
MUST be specifically requested during the initial arrangement conference <i>and</i> requires Crematory Manager approval. Cremation will be scheduled to occur within 72 hours of Neptune Society receiving the CA Disposition Permit from the SD Vital Records Office.	
SCATTERING AT SEA (for outside cremations)	\$250.00
Unattended scattering of cremated remains. Family is not present on the boat. CA Disposition Permit included.	
SHIPPING CREMATED REMAINS via USPS within the US (in a DURABLE PLASTIC URN only)	\$200.00
USE OF CEREMONIAL RENTAL CASKET FOR SERVICES	\$900.00
Mountain-Oak Medium Wood Ceremonial Casket with Cardboard Insert and Rosetan-Colored Crepe Fabric Interior. Use of the Rental Casket for a formal viewing <i>requires embalming</i> which is an additional charge (as referenced on GPL).	
USE OF FACILITIES & STAFF FOR VIEWING in Memorial Chapel during business hours (for 2 hours)	\$500.00
Add \$200.00 for AFTER HOURS or WEEKENDS	
USE OF FACILITIES & STAFF FOR FUNERAL CEREMONY in Memorial Chapel during business hrs (for 2 hours)	\$500.00
Add an additional \$200.00 for AFTER HOURS or WEEKENDS	
USE OF FACILITIES & STAFF FOR MEMORIAL SERVICE in Memorial Chapel during business hrs (for 2 hours)	\$500.00
Add an additional \$200.00 for AFTER HOURS or WEEKENDS	
USE OF EQUIPMENT & STAFF FOR GRAVESITE SERVICE during business hours (for 2 hours)	\$700.00
Add additional \$200.00 for AFTER HOURS or WEEKENDS	
URNS (Adult-sized)	\$150.00 and above
RE-FILING of DISPOSITION PERMIT with SD Vital Records Office	\$25.00 per re-file

NEPTUNE SOCIETY SETS THE FOLLOWING CONDITIONS ON ITS SALES AND SERVICES:

1. Prices are valid for services provided to individuals 14 years and older.
2. Children under age 14, will be charged a percentage of the published rate for services provided equal to 50%.
3. Prices are valid for weights up to 295 lbs.
4. Decedents (*of any age*) over 295 lbs will be charged an additional \$500.00 to cover ancillary overhead expenses.
5. We CANNOT cremate individuals weighing over 400 lbs.
6. Sheltering of Remains/Refrigeration Fee is \$100.00 per day (when applicable).
7. We DO NOT offer Witness Cremations or Witness Insertions.
8. We DO NOT have reception facilities in our Memorial Chapel
9. We DO NOT allow outdoor receptions at our facility.
10. NO FOOD or DRINKS (other than bottled water) are permitted on the premises for services.
